


### SAP Concur App Center Administration Guide

Learn how to enable and administer partner apps that maximize the value of your SAP Concur solutions.





## How to Enable and Administer Integrated Partner Apps

#### Leverage App Center solutions to optimize your program

The App Center offers over 200 certified, pre-built partner applications that help your business increase insight and control. This guide covers how to enable and manage apps which connect to and enhance the SAP Concur solutions you already have in place.

#### What can I find in the App Center?

#### **User Connections:**

Individual employees can link their SAP Concur accounts to a variety of enduser applications to improve their travel experience. Travelers have the ability to connect to rideshare, taxi, catering, parking, and other apps that send e-receipts to Concur Expense, helping to simplify expense reporting on the road.

#### **TripLink Connections:**

If your company uses TripLink, employees can easily connect to over 15 of the world's most popular travel suppliers such as United, Delta, Marriott, and even Airbnb. Once connected, your corporate rates and travel policies will be applied to supplier direct bookings and outside itineraries will be delivered back into your managed travel program.

#### **Enterprise Applications:**


These applications can be enabled by authorized Concur administrators at a site level. There are a wide variety of integrations that make it easier to accomplish extraordinary results in your program without devoting extra time. Integrations allow you to manage tax compliance, automate invoice payments, and post expense and invoice data to your ERP, among other examples.


Partner solutions are available for an assortment of unique business needs, with integrations for various industries and geographies and options for small, midsize, and enterprise organizations.

### Access and Visibility for Your Users

#### **How do I access the App Center?**

The App Center is available at concur.com/appcenter and in the App Center tab within SAP Concur. Use the search and categories to find what you need.





#### **In-product App Center experience:**

- Connections (end user apps) are pre-filtered for users based on their location and whether they have access to Concur Travel, Concur TripLink, or Concur Expense.
- Administrators can enable many enterprise applications directly from the partners' App Center listing pages.

#### **Need more information?**

## How to Enable Enterprise Applications

#### **Enterprise app enablement requirements:**

Once you have contracted with a partner to utilize their service, an authorized administrator is required to enable the application.

The individual enabling the application must first authorize the sharing of data with that application. This is done through a Letter of Authorization (LOA). Depending on the solution, the LOA may be provided to you by the partner or be included in the Terms & Conditions when you enable the app in the App Center.



#### Data sharing and security:

All partners must go through a certification process prior to being listed in the App Center. Data is only shared upon completing the connection process and is limited to only information necessary for the integration. The "Shared Information" section of the Terms & Conditions outlines data exposed to the partner. A link is provided to view individual fields that are exposed.

## How to Enable Enterprise Applications


#### Depending on the app, it will be enabled in one of two ways:

#### **Enablement via the App Center listing:**

- 1. Click "Connect" on the partner's App Center listing page.
- 2. Check the boxes to accept the terms and click "I agree".
- 3. In the resulting pop-up, enter in the activation code or login information provided by the partner after contracting with them. In some cases, you will be prompted to create a new login.
- **4.** Follow the instructions provided by the partner to complete your activation in the following screens.
- 5. Done! Data can now flow between the solutions.

#### **Enablement via the Enable Partner Applications settings:**

- Work with the partner to sign a contract, submit a signed LOA, and plan your roll-out.
- In the SAP Concur Administration menu, click Company >> Web Services >> Enable Partner Applications.
- 3. Select the partner app you are connecting and then click "Enable" at the top of the page, then "Yes" to confirm
- 4. Inform the partner. They will need to take additional steps to complete your roll-out.



#### **Enterprise application disablement:**

If you need to disconnect an enterprise application, you can do that by returning to the same pages and then selecting the option to disconnect.

### How Users Enable Connection Applications


#### What actions can employees take from the App Center?

Individual employees can connect to approved user applications or inquire with partners whose solutions are relevant to their department's needs.

Employees cannot download apps via the App Center and there are no transactions facilitated in the App Center – it is simply a place to discover and connect to apps.


### How to enable a connection app via the App Center:


Click "Connect", accept the T&Cs, and then follow the instructions in the pop-up to login or create an account.



#### Connecting via the SAP Concur mobile application.

You can connect to certain user applications via the SAP Concur mobile application. To access this feature, select the "settings" menu in the top left, and then click "Connect to Apps".








### How to Manage User Connection Applications

#### How to access the Manage User Applications menu:

In the SAP Concur Administration menu, click "Company" >> "Web Services" >> "Manage User Applications".



#### Disabling applications in the Manage User Applications settings:

- Hides the listing tile from the App Center for all of your company's SAP Concur users
- Completely removes the ability for anyone to connect to the app
- Existing connections will be disabled.

## Best Practices for Identifying and Rolling Out Apps

#### How can I identify which apps would be best for my business?

Follow these tips to find the most beneficial apps for your company:

- Review your data: Work with your SAP Concur account team to review your App Center Insights Dashboard to see potential savings areas in your company's spend history.
- Ask your account team: Your account team can suggest apps that are relevant for you.
- Learn from your peers: Join the SAP Concur Community at community.concur.com and attend SAP Concur events like Fusion, Fusion Exchange, and User Groups to get help from other customers.
- **Explore App Center resources:** Visit the App Center at concur.com/appcenter or our Resources page at go.concur.com/app-center-resources.

#### What are some best practices to roll out apps to my users?

To ensure a successful roll out, follow these 5 key steps:

- **1. Champions:** Start at the top by securing an Executive Sponsor, then look outside of IT for early adopters who can help promote change.
- 2. **Content:** Inside the SAP Concur App Center, you'll find brochures with messaging you can use for your communications. Let employees know how the solution will affect them and the way they work.
- **3. Social:** Promote and educate employees about the change using options like video conferences, webinars, social pages, chat tools, and lunch-and-learns.
- **4. Rewards:** Highlight quick wins; reward and spotlight power users in your organization and how they're benefiting from the apps.
- **5. Resources:** Know who to ask when you or your employees have questions.
  - Your App Center partner is your first line of support, as they know the ins and outs of their integrations with SAP Concur solutions. If they can't provide the solution, they will log a ticket on your behalf.
  - Your peers in the SAP Concur Community at community.concur.com.
  - Your SAP Concur account team and the App Center team are happy to help answer general App Center or partner questions.

### **Application Support Process** & Resources

#### Where do I find support for App Center applications?

App Center partners provide first-level support for their integrations with SAP Concur. To contact App Center partners for application support, please follow these steps:

- Go to the SAP App Center at concur.com/appcenter or within the App Center tab in the SAP Concur product.
- 2. Use the search bar to find the partner application
- Click on the partner's App Center listing tile
- 4. Click on the blue "Support" link found in the middle of the page
- The Support link will give you the App Center partner's contact information for support. If the App Center partner needs to work with SAP Concur to solve the issue, they will submit a case on your behalf.
